ORDER

As part of the Ease of Doing Business programme and the Business Reform Action Plan (BRAP) 2019, Department of Industrial Policy and Promotion (Ministry of Commerce, Government of India) has broadened the scope of the inspection reforms with the aim of bringing more transparency to inspection procedures.

In view of above, Inspectorate of Factories and Boilers, Altinho, Panaji has also adopted the following recommendations of the BRAP 2019:

Recommendation Number	Recommendation						
66	Mandate surprise inspection or inspections based on complaints are conducted with specific permissions from the respective Head of Department						
65	Mandate that inspections (except in case of complaint based inspections) shall be limited to the checklist						

Vide this Order, it is hereby mandated that all surprise inspections and inspections based on complaints shall be conducted with due authorization from the Chief Inspector of Factories & Boilers. In the absence of the Chief Inspector of Factories & Boilers, Officer holding the charge of Chief Inspector of Factories & Boilers is authorized to issue such permission. The format of such authorization letter has been enclosed herewith.

It is further mandated that all inspections, except in case of inspections based on complaints, shall be limited to their corresponding checklists.
